DESCRIPTION

S.P.A.PLAST-403 is a high range water-reducer and super plasticizing admixture. It meets the requirements of the following standards: ASTM C494/C494 M TYPE F, EN 934, ISIRI 2930

APPLICATION

- Enables production and transportation of concrete in normal weather conditions
- Slabs, foundations, columns, shear and retaining walls, deck bridges, etc.
- Production of hard floors

ADVANTAGES

- Reduces water-cement ratio in the range of %12 to 20%
- Increases workability and workability retention of concrete
- Improves pumpability of concrete
- It can be used with all types of Portland cement
- Prevents creep and shrinkage of concrete
- Increases the compressive strength of concrete
- Reduces permeability

DOSAGE

The optimum dosage of S.P.A.PLAST-403 can be determined by trials in the site. Depending on concrete mix design (sizes and types of aggregates, cement content, water/cement ratio, ambient temperature and concreting conditions), a dosage of between 0.45 and 1.2 percent by weight of cement or cementitious material is recommended.

For use with other range of dosage, contact ABADGARAN GROUP Technical Services Department.

DIRECTION OF USE

- 1-S.P.A.PLAST-403 could be added to a part of concrete mixing water then added to the concrete mix.
- 2- S.P.A.PLAST-403 could be added to the concrete mix during the mixing cycle at the same time as the water or the aggregate or it could be added to ready-mix concrete before placing concrete.
- 3- Admixtures must be weighed carefully.
